

UNIVERSAL BUSINESS MATRIX END USER LICENSE AGREEMENT

IMPORTANT-READ CAREFULLY: This End-User License Agreement ("EULA") is an agreement between you (either an individual person or a single legal entity, referred to in this EULA as "You") and Universal Business Matrix, INC, located at 803 Kirkland Ave., Suite 200, Kirkland, WA 98033 ("UBmatrix") for the UBmatrix software product that accompanies this EULA, including any associated media, printed materials and electronic documentation (the "Licensed Product"). The Licensed Product also includes any software updates, add-on components, web services and/or supplements that UBmatrix may provide to You or make available to You after the date You obtain Your initial copy of the Licensed Product, but only to the extent that such items are not accompanied by a separate license agreement or terms of use. By installing, copying, downloading, accessing or otherwise using the Licensed Product, You agree to be bound by the terms of this EULA. If You do not agree to the terms of this EULA, do not install, access or use the Licensed Product; instead, You should contact UBmatrix at the addresses indicated below for a full refund.

1. SOFTWARE PRODUCT LICENSE

Subject to the terms of this EULA, UBmatrix hereby grants you a personal, non-exclusive, non-transferable, limited license to install and use one (1) copy of the software and its associated media, printed materials and electronic documentation ("Licensed Product") on a single computer, device, workstation, terminal, server or other digital electronic device ("Device") for internal business purposes only.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

General Limitations and Restrictions. Except as specifically provided herein, You may not, in whole or in part: (a) copy the Licensed Product, (b) distribute copies of the Licensed Product, in whole or in part, to any third party; (c) modify, adapt, translate, reverse engineer, make alterations, decompile, disassemble or make derivative works based on the Licensed Product; (d) use, rent, loan, sub-license, lease, distribute or attempt to grant other rights to the Licensed Product to third parties; or (e) use the Licensed Product to act as a service bureau or application service provider, or to permit remote access to the Licensed Product by any kind to any third party. Nothing in this Agreement shall give You the right or license to use any trademarks used in connection with the Licensed Product including without limitation "UBmatrix" and/or any marks of UBmatrix's providers and suppliers.

License Key. Except as specifically provided herein, You may not exercise Your rights to the Licensed Product unless you have purchased a valid License Key or unlock code. A separate License Key is required for each Device for which the Licensed Product is installed. A "License Key" is a unique unlock code for each Licensed Product. Such license keys are tied to the specific Device that the Licensed Product has been loaded on and are obtained directly from UBmatrix.

Copy Protection. The Licensed Product may include copy protection technology to prevent the unauthorized copying of the Licensed Product or may require original media for use of the Licensed Product on the Device. It is illegal to make unauthorized copies of the Licensed Product or to circumvent any copy protection technology included in the Licensed Product, with the exception of a single back up copy needed for backup and/or archival purposes. Each copy must reproduce all copyright and other proprietary rights notices on or in the Licensed Product. If this Licensed Product contains documentation that is provided only in electronic form, You may print one (1) copy of such electronic documentation. You may not copy the printed materials accompanying the Licensed Product.

Demonstration/Evaluation. If the Licensed Product is labeled "Not For Resale", "Internal Use", "Beta", "Demo" or "Evaluation" then, notwithstanding other sections of this EULA, Your use of the Licensed Product is limited to use for non-commercial, demonstration, test, or evaluation purposes and You may not resell, or otherwise transfer for value, the Licensed Product.

Separation of Component Parts. The Licensed Product is licensed as a single product. Its component parts may not be separated for use on more than one Device unless expressly permitted by this EULA.

Support Services. Provided that You are current with the corresponding support and maintenance fees, UBmatrix will provide You with support services related to the Licensed Product ("Support Services") as specified on the UBmatrix web site and as the same may be changed or revised from time to time by UBmatrix without notice. Any bug fixes, updates, or related materials made generally available to You as part of the Support Services are considered part of the Licensed Product and subject to the terms and conditions of this EULA. You acknowledge and agree that UBmatrix may use technical information You provide to UBmatrix as part of the Support Services for its business purposes, including for product support and development. UBmatrix will not use such technical information in a form that personally identifies You.

Termination. Without prejudice to any other rights, UBmatrix may terminate this EULA if You fail to comply with the terms and conditions of this EULA. In such event, You must destroy all copies of the Licensed Product and all of its component parts.

Proprietary Legends. Company must retain all legends relating to copyright, trademarks, patents or confidentiality on all copies of the Licensed Product, and Company must reproduce such notices on any copies of the Licensed Product or any portion of Licensed Product.

3. INTELLECTUAL PROPERTY RIGHTS AND CONFIDENTIALITY. All title and intellectual property rights in and to the Licensed Product (including but not limited to any images, video, audio, , text, and "applets" incorporated into the Licensed Product), the accompanying printed materials, and any copies of the Licensed Product are owned by UBmatrix or its suppliers. All right and title in and to the content that is not contained in the Licensed Product, but may be accessed through use of the Licensed Product, is the property of the respective content owners and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants You no rights to use such content. You will take those reasonable steps necessary to protect UBmatrix and its suppliers' proprietary rights in the Licensed Product related to Your use and possession of the same, including but not limited to maintaining the confidentiality of your passwords, if any. You will, at Your own cost and expense, protect and defend UBmatrix's ownership of the Licensed Product against all claims, liens and legal processes of Your creditors and will keep the Licensed Product free and clear of all such claims, liens and processes. You will keep the Licensed Product confidential and will not disclose or publish it, or any part of it, to others, except as specifically provided herein. All design elements of the Licensed Product, including but not limited to the design, text, graphics, interfaces and the selection and arrangement thereof, are protected by copyrights owned by UBmatrix. ALL RIGHTS NOT EXPRESSLY GRANTED HEREIN ARE RESERVED TO UBMATRIX, INC.

Third Party Content. All title and intellectual property rights in and to third party content provided hereunder, including without limitation public documents, sample files and taxonomies authored by the American Institute of Certified Public Accountants (AICPA) and XBRL International, are the property of the respective content owners and are protected by applicable copyright or other intellectual property laws and treaties. Use of such third party content may be subject to additional license terms and conditions and Your use of such third party content is conditioned on your agreement to comply with such additional terms and conditions. In no event will You modify, remove, or obscure the copyright and proprietary notices accompanying such third party content.

2. **4. FEES AND TAXES.** By agreeing to this EULA, You acknowledge You have paid or are obligated to pay UBmatrix the applicable license fee for the Licensed Product. You shall pay all taxes and other governmental charges, however characterized (except based on UBmatrix's income), in connection with Your licensing of the Licensed Product.

3. **5. U.S. GOVERNMENT LICENSE RIGHTS.** All Licensed Product provided to the U.S. Government pursuant to solicitations issued on or after December 1, 1995 is provided with the commercial license rights and restrictions described elsewhere herein. All Licensed Product provided to the U.S. Government pursuant to solicitations issued prior to December 1, 1995 is provided with RESTRICTED RIGHTS as provided for in FAR, 48 CFR 52.227-14 (JUNE 1987) or DFAR, 48 CFR 252.227-7013 (OCT 1988), as applicable.

4. **6. EXPORT RESTRICTIONS.** You acknowledge that the Licensed Product is of U.S. origin. You agree to comply with all applicable international and national laws that apply to the Licensed Product, including the U.S. Export Administration Regulations, as well as end-user, end-use and destination restrictions issued by U.S. and other governments.

5. **7. APPLICABLE LAW.** If this Licensed Product is purchased in Japan, Korea, China, or any country of Southeast Asia, then this EULA is governed by the laws of Japan. This EULA shall otherwise be deemed made in the State of Washington, U.S.A., and shall be governed by the substantive laws of Washington. This EULA will not be governed by the conflict of laws rules of any jurisdiction or the United Nations Convention on Contracts for the

6. **8. LIMITED WARRANTY.** UBmatrix warrants that the Licensed Product will perform substantially in accordance with the documentation for a period of ninety (90) days from the date of delivery. Any supplements or updates to the Licensed Product, including without limitation, any (if any) service packs or updates provided to you after the expiration of the ninety (90) day Limited Warranty period are not covered by any warranty or condition, express, implied or statutory. THE LIMITED WARRANTY THAT APPEARS ABOVE IS THE ONLY EXPRESS WARRANTY MADE TO YOU AND IS PROVIDED IN LIEU OF ANY OTHER EXPRESS WARRANTIES (IF ANY) CREATED BY ANY DOCUMENTATION OR PACKAGING. EXCEPT FOR THE LIMITED WARRANTY AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, UBMATRIX AND ITS SUPPLIERS PROVIDE THE SOFTWARE AND SUPPORT SERVICES (IF ANY) *AS IS AND WITH ALL FAULTS*, AND HEREBY DISCLAIM ALL OTHER WARRANTIES AND CONDITIONS, EITHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES, DUTIES OR CONDITIONS OF MERCHANTABILITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY OR COMPLETENESS OR RESPONSES, OF WORKMANLIKE EFFORT, OF LACK OF VIRUSES AND OF LACK OF NEGLIGENCE. ALSO, THERE IS NO WARRANTY OR CONDITION OF TITLE, QUIET ENJOYMENT, QUIET POSSESSION AND CORRESPONDENCE TO DESCRIPTION OR NON-INFRINGEMENT WITH REGARD TO THE SOFTWARE.

7. **9. LIMITATION ON REMEDIES.** Should any Licensed Product fail to meet its warranty, UBmatrix and its suppliers' entire liability and your exclusive remedy shall be, at UBmatrix' option, (a) return of the price paid (if any) for the Licensed Product, or (b) repair or replacement of the Licensed Product. UBmatrix shall have no liability or obligation if the failure of the Licensed Product has resulted from accident, abuse, misapplication, abnormal use or a virus. Any replacement Licensed Product will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Outside the United States, neither these remedies nor any product support services offered by UBmatrix are available without proof of purchase from an authorized international source. EXCLUSION OF INCIDENTAL, CONSEQUENTIAL AND CERTAIN OTHER DAMAGES.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL UBMATRIX OR ITS SUPPLIERS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, FOR BUSINESS INTERRUPTION, FOR PERSONAL INJURY, FOR LOSS OF PRIVACY, FOR FAILURE TO MEET ANY DUTY INCLUDING OF GOOD FAITH OR OF REASONABLE CARE, FOR NEGLIGENCE, AND FOR ANY OTHER PECUNIARY OR OTHER LOSS WHATSOEVER) ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE THE LICENSED PRODUCT, THE PROVISION OF OR FAILURE TO PROVIDE SUPPORT SERVICES, OR OTHERWISE UNDER OR IN CONNECTION THIS EULA, EVEN IN THE EVENT OF NEGLIGENCE, STRICT LIABILITY, BREACH OF CONTRACT OR BREACH OF WARRANTY OF UBMATRIX OR ANY SUPPLIER, AND EVEN IF UBMATRIX OR ANY SUPPLIER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

9. **11. LIMITATION OF LIABILITY AND REMEDIES.** NOTWITHSTANDING ANY DAMAGES THAT YOU MAY INCUR FOR ANY REASON WHATSOEVER (INCLUDING, WITHOUT LIMITATION, ALL DAMAGES REFERENCED ABOVE AND ALL DIRECT OR GENERAL DAMAGES), THE ENTIRE LIABILITY OF UBMATRIX AND ANY OF ITS SUPPLIERS UNDER ANY PROVISION OF THIS EULA AND YOUR EXCLUSIVE REMEDY FOR ALL OF THE FOREGOING (EXCEPT FOR ANY REMEDY OF REPAIR OR REPLACEMENT ELECTED BY UBMATRIX WITH RESPECT TO ANY BREACH OF THE LIMITED WARRANTY) SHALL BE LIMITED TO THE GREATER OF THE AMOUNT ACTUALLY PAID BY YOU FOR THE SOFTWARE OR U.S. \$5.00. THE FOREGOING LIMITATIONS, EXCLUSIONS AND DISCLAIMERS (INCLUDING SECTIONS 8, 9, AND 10 ABOVE) SHALL APPLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EVEN IF ANY REMEDY FAILS ITS ESSENTIAL PURPOSE.

10. **12. ENTIRE EULA.** This Agreement (including any addendum or amendment) constitutes the entire agreement between the parties pertaining to the subject matter hereof, and supersedes all prior or contemporaneous written or oral agreements existing between the parties. Any modifications of this Agreement must be in writing and signed by both parties. To the extent the terms of any UBmatrix policies or programs for support services conflict with the terms of this Agreement, the terms of this Agreement shall control.
